AMENDMENT TO RESTRICTIVE COVENANTS

COUNTY OF BUNCOMBE

THIS AMENDMENT, entered into this 10th day of July, 2008 by and between the undersigned owners of lots within the restricted community known as "Alpine Mountain" as hereinafter set forth, Grantors and ALPINE MOUNTAIN HOMEOWNERS ASSOCIATION, INC., Grantee.

#### WITNESSETH:

WHEREAS, the undersigned are owners of lots and parcels of land located within a tract of land, originally consisting of approximately 502.60 acres, more or less, the boundary of which is shown on a plat duly recorded in the Office of the Register of Deeds for Buncombe County, North Carolina in Plat Book 50, Page 6; and

WHEREAS, the property owned by the undersigned owners has been made subject to protective covenants and restrictive agreement by documents recorded in the Office of the Register of Deeds for Buncombe County, North Carolina in Deed Book 1438, Pages 102-106 and Deed Book 1638, Pages 118-122 (hereafter, together with subsequent duly adopted amendments thereto, the "Restrictive Covenants"); and

WHEREAS, the community governed by the Restrictive Covenants is known as "Alpine Mountain" and the property owners association for said community is the Alpine Mountain Homeowners Association, Inc. (hereafter the "Association"); and

WHEREAS, specific parcels of land have been released from the applicability of the Restrictive Covenants and are no longer included within the Alpine Mountain community as evidenced by an Amendment to Restrictions recorded in the Office of the Register of Deeds for Buncombe County, North Carolina in Book 4443, Page 524-577; and

WHEREAS, Lots 1 through 8 as shown on Plat Book 42, Page 35 have been specifically excluded from the applicability of the Restrictive Covenants pursuant to a recital in Deed Book

Bresaul b. Precord & Return To: Wm. Michael Begley Box 9 1438, Page 102, but such exclusion is generally thought to have been an error in drafting the provision that was intended to exclude Lots 1 and 7, the two "reserved" lots; and

WHEREAS, those undersigned owners of lots so excluded join herein for the additional purpose of acknowledging the applicability of the Restrictive Covenants, and to the extent necessary, to expressly make each such owner's excluded lot subject to the Restrictive Covenants as herein amended; and

WHEREAS, the undersigned owners recognize that certain changes in the Restrictive Covenants and the manner by which the Association has administered the Restrictive Covenants are appropriate in order to promote greater fairness and good will in the neighborhood and to create clarity in certain matters heretofore not adequately addressed in the Restrictive Covenants.

NOW THEREFORE, in consideration of the foregoing premises and other good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, the parties amend the Restrictive Covenants as follows:

- 1. Definition of Lot for Property Deemed to be a Homestead Lot. Contiguous property of an owner, not exceeding twelve (12) acres, upon which is located no more than one (1) dwelling which is or has been occupied or for which a certificate of occupancy has been issued shall be considered a "homestead lot", and consequently shall be one "lot" for all purposes governed by the Restrictive Covenants, including assessment for the next succeeding assessment period after the homestead lot has been approved by the Association. Contiguous parcels meeting the foregoing requirements but titled in different names or entities (i.e. partnership, corporation, LLC, in trust, etc.), for estate planning purposes or otherwise, may nevertheless be eligible for homestead status so long as the Association determines that there exists a substantial identity or common ownership among the differently titled owners.
- 2. Definition for Lot or Lots for Property Not Eligible to be a Homestead Lot. Property failing to meet the requirements of a homestead lot shall be deemed to be a "lot" or "lots" for all purposes governed by the Restrictive Covenants, including assessment, as follows:
  - a. Contiguous property, containing no more than six (6) acres, shall be one lot.
- b. Contiguous property, containing more than six (6) acres but not more than twelve (12) acres, shall be two (2) lots.
- c. Contiguous property, containing more than twelve (12) acres but not more than eighteen (18) acres, shall be three (3) lots.
- d. Contiguous property, containing more than eighteen (18) acres but not more than twenty-four (24) acres, shall be four (4) lots.
- e. Contiguous property, containing more than twenty-four (24) acres, shall be five (5) lots.

For purposes of this Section 2, a reference to contiguous property shall include property which is a composite tract of separate parcels titled in different names or entities (i.e. partnership, corporation, LLC, in trust, etc.), for estate planning purposes or otherwise, so long as the Association determines that there exists a substantial identity or common ownership among the differently titled owners.

- 3. Annual Assessment Equal for Each Lot. The annual assessment, which shall exclude the assessment for road maintenance, for each lot shall be equal.
- 4. Road Maintenance Assessment Allocated by Neighborhood. The assessment for road maintenance shall be determined as follows:
- a. Lower Neighborhood. The Lower Neighborhood shall include those portions of subdivision roads located within and shown on Plat Book 42, Page 35, the plat by which Lots 1 through 27 were sold and conveyed.
- **b. Upper Neighborhood.** The Upper Neighborhood shall include all subdivision roads or portions of subdivision roads of Alpine Mountain not located in the Lower Neighborhood.
- c. Lower Neighborhood Road Maintenance Fund. A separate fund will be created in the Association budget and accounting for road maintenance in the Lower Neighborhood. Upon assessment of lots for road maintenance by the Association, one-half of the budget for Lower Neighborhood road maintenance shall be allocated equally among and collected from those lots in the Lower Neighborhood and one-half of said budget shall be allocated equally among and collected from those lots in the Upper Neighborhood. In separately determining the assessment amount for lots in each neighborhood, the Association may consider the historical collection rates from the respective neighborhoods. Any surplus shall be maintained in the separate Lower Neighborhood Road Maintenance Fund. Administrative responsibility shall be vested solely in the Association. However, the Association may appoint an Advisory Road Maintenance Committee composed of lot owners in the Lower Neighborhood.
- d. Upper Neighborhood Road Maintenance Fund. A separate fund will be created in the Association budget and accounting for road maintenance in the Upper Neighborhood. Upon assessment of lots for road maintenance by the Association, all of the budget for Upper Neighborhood road maintenance shall be allocated equally among and collected from those lots in the Upper Neighborhood. In determining the assessment amount for lots in the Upper Neighborhood, the Association may consider the historical collection rates from said lots. Any surplus shall be maintained in the separate Upper Neighborhood Road Maintenance Fund. Administrative responsibility shall be vested solely in the Association. However, the Association may appoint an Advisory Road Maintenance Committee composed of lot owners in the Upper Neighborhood.
- 5. Appurtenance to Title. This amendment shall be appurtenant to and run with title to lots governed by the Restrictive Covenants and shall be binding upon current owners, their heirs, legal representatives, successors and assigns.

- 6. Documentation of Future Amendments. This amendment and any future amendment to the Restrictive Covenants shall be deemed valid and binding upon owners, their heirs, legal representatives, successors and assigns, and shall be appurtenant to and run with title to properties governed by the Restrictive Covenants if a document setting forth the terms of the amendment is executed by the Association and recorded in the Office of the Register of Deeds for Buncombe County, North Carolina, together with a certification that the amendment was duly adopted pursuant to the requirements of the Restrictive Covenants, other governing Association documents, including By-Laws, and the relevant laws of the State of North Carolina.
- 7. This Amendment Supplemental to Contemporaneous Replacement of Restrictive Covenants. In the event that an amendment of the existing Restrictive Covenants is contemporaneously offered to the owners of lots within Alpine Mountain and approved as replacement Restrictive Covenants, the terms of this amendment are intended to survive said replacement Restrictive Covenants and shall be supplemental to and merged into said replacement Restrictive Covenants. It is contemplated that said replacement Restrictive Covenants, if approved, shall make provision for the continued applicability of the provisions of this amendment.




